

**CITY OF RIFLE, COLORADO
ORDINANCE NO. 27
SERIES OF 2015**

AN ORDINANCE OF THE CITY OF RIFLE, COLORADO, PROVIDING FOR
A SUPPLEMENTAL APPROPRIATION FOR THE YEAR ENDING
DECEMBER 31, 2015.

WHEREAS, by Resolution No. 22, Series of 2014, the Rifle City Council adopted its annual budget for the fiscal year beginning January 1, 2015 and ending December 31, 2015 (“2015 Budget”) after duly-noticed public hearings; and

WHEREAS, based upon the 2015 Budget as adopted, the Council further approved by Ordinance No. 17, Series of 2014 the Annual Appropriation for fiscal year 2015 (“2015 Annual Appropriation”) after duly-noticed public hearings; and

WHEREAS, at the time the 2015 Annual Appropriation was adopted, certain expenses were not known, and operating transfers between funds were not anticipated; and

WHEREAS, funds are available in the City Treasury to meet the increased expenses; and

WHEREAS, the City Council desires to approve the additional appropriations set forth herein in order to ensure effective and fiscally responsible administration of City business for the remainder of fiscal year 2015.


NOW, THEREFORE, THE COUNCIL OF THE CITY OF RIFLE, COLORADO, ORDAINS THAT:


